In accordance with Iowa Administrative Code 55.5(3), the first quarterly report expected by DIA should contain data required by that rule for the period from Oct 1, 2024, through Dec 31, 2024 and shall be submitted no later than Jan 15, 2025. Additional information will be distributed at a later date to registered health care employment agencies regarding the method by which such data should be submitted to DIA.

Additionally, each CNA working for their agency who has performed at least one day of paid nursing or nursing-related duties [**in a long-term care facility**] **must** be reported to the Iowa Direct Care Worker Registry. You will need to log in to your account to do this.
